

► Capital City: Seoul

▶ **Population:** 51.7 million = Washington×6.64 (worldpopulationreview.com)

► GDP (https://tradingeconomics.com/south-korea/gdp):

2023 GDP	\$1,712,790,000,000 (World Bank)
Economic Growth Rate (2023)	Up 1.62% year on year (Korea Economic Research Institute)

- ▶ Typical Household Income: Abt. US\$3,700 per month in Q1, 2023 (Statistics Korea)
- ▶ Imported Food Value/Ratio: About 60%
- ▶ The United States is the leading supplier of imported agricultural products to Korea with a 30 percent market share. (2023)
- Top competitors: China(11%), Australia(10%), New Zealand(4%), Germany(4%), Spain(3%)
- ► Washington-grown or processed food and agriculture exports in 2023: South Korea is the 5th largest export market. (WISER Trade. Wheat numbers from USDA, U.S. Wheat Associates, and Washington Grain Commission. All statistics reflect Calendar Year 2023.)
