General Focus Check-In Meeting – May 21, 2024

Focus on Food Initiatives – Katie Rains, WSDA

- Planning for future financial and policy requests to governor and legislation for next session in January.
- Recap on Focus on Food Initiative.
 - Started as a Director's initiative in 2019. Core concept is that: food is the cornerstone of agriculture and a tool for bridging the urban and rural divide.
 - Explore programs that support the food supply chain.
 - Through Covid, our agency budget doubled, and the service need has also increased.
 - WSDA has awarded \$250M in 4 years, also state food purchasing and food reserves through FA, and other program grants, (detailed in the slideshow)
 - Farm to School grants, Meat and Poultry grants.
- WA State Equity and Environmental Justice (HEAL act 2021)
 - Requires ongoing dialogue.
 - Coordinated effort with 7 state agencies to reduce environmental harm, including food disparities.
- PEAR Executive Order 2022
 - o Requires a shift in how we operate as a government to improve equity.
- Community Engagement Plan
 - o CDC definition: working collaboratively with regional neighbors.
 - o It is a foundation to build relational equity, not a one-time event.
 - o Surveys, UW Survey, to gather information from clients.
 - Stakeholder engagement plan for farm and food businesses.
- WSDA is working on short term goals, to put together one pagers on current programs. Also
 gather information on priorities and needs of stakeholders to build short- and long-term goals
 for the Farm Bill, expanding work capacity, reviewing our communication networks.
- As WSDA's policy agenda is developed, this group will receive monthly updates as well as the stakeholder survey. Folks are welcome to contact me any time with policy inquiries or comments krains@agr.wa.gov AND food@agr.wa.gov. Thanks!

Advocacy Updates – Claire Lane, AHNC

- Busy weekend in Washington DC.
- The House Released their Farm Bill Language, which include some big problems for hunger.
- Thank you to 98 organizations who signed the letter to Washington's delegation.
- Cut \$30B from SNAP over the next decade. Underlying Summer EBT and TEFAP and SNAP is the
 Thrifty Food Plan, which had a small bump in 2022 after the first review in 40 years. The House
 wants to reevaluate the Thrifty Food Plan every 5 years, but also propose not adjusting the
 underlying formula.
- There are also Conservation issues with the Bill, it doesn't spend any of the climate, smart AG, and conservation money. The vote is on Thursday, a WA member of our delegation is on the committee.
- Senate AG Farm Bill does not cut SNAP and does use Conservation budget.
- Another hearing tomorrow to limit SNAP choices on food in the Appropriations Committee.
- State
 - DSHS and OSPI, successfully funded Summer EBT to continue Pandemic EBT and is now permanent. Encourage your clients to enroll in SNAP/TANF to automatically enroll in

Summer EBT, link below to the form to fill out Alternate Household Income Form application. If not pre-registered, will have to wait for summer to enroll, and will be delayed application process. The Form also tells schools how many students are in financial need and will get fee waivers and free meals.

Sharing

- C: Our numbers are continuing to increase.
- OSL just opened our new 13,000 square foot commercial kitchen and cold, frozen, and dry storage on 5/20. It is equipped to do 15,000 meals a day. We are currently doing 7000 meals a day. We are providing storage to Meals Partnership Coalition members and our Food Bank partners as well for overflow storage.
- Q: This is my first meeting are the shareouts general questions or specific to certain operations?
 - A: Whatever you want them to be, any challenges or successes. Or sharing information that you've learned.
- C: FYI only article in NYT this morning about free school meals.
- C: We're going to need two agendas this fall for 3 initiatives on the November ballot, which would repeal three initiatives and all three would negatively impact the hunger relief system. Budgets are rumored to be tight.
- I was sad to miss the "Nonpartisan Advocacy: How 501(c)(3)s Can Educate and Advocate During Election Season" training on 5/17-- was this recorded? Will any content be shared? Thank you in advance!
 - That webinar was put on by national partners and I don't have a recording, but AHNC is planning to do a WA-specific version this summer. FYI: any organization that receives FNS support MUST offer nonpartisan voter registration. So if your org receives TEFAP food, participates in Summer Meals, conducts SNAP outreach... that means you! FA Resiliency Grants – Anna Berrey Hamill, WSDA FA

- Round 4 (SFY 2025) application process will be composed of two phases of submissions and scoring.
 - o Phase 1: Request for Concept Proposal is closed.
 - 230 proposals submitted, \$24M in requests for \$5.3M available.
 - Review and selection for Phase 2: Full Application is in process.
 - o Notifications will be sent around June 1, 2024.
