



Sharciga Ugu dambeeyo ee Iskaashiga Ururada Diimeedka iyo Xaafada

Ogaysiiska Qoraalka ah ee Xaquuqaha Ka faa'ideystayaasha/Macmiilka

Sababtoo ah barnaamijkeena waxaa gabii ahaan ama qeyb ahaan taageeray kaalmada maaliyada ka timid Dowlada Dhexe, waxaa nalooga baahanyahay inaan bixino ogeysiin qoran oo Xaquuqaha Ka faa'ideystaha/Xaquuqaha Macmiilka ee Barnaamijka Cuntada Kaalmada ah (Commodity Supplemental Food Program, CSFP), Barnaamijka Kaalmada Cunto ee Xaalada Degdega ah (The Emergency Food Assistance Program (TEFAP), Kaalmada Iibsashada Cuntada Deegaanka (Local Food Purchasing Assistance, LFPA) iyo sharuudaha gudbinta oo CSFP iyo TEFAP, oo ku ogaysiinayo in:

- Waxaa laga yaabaa inaan kugu takoorin si ku saleysan diin, caqiidad diimeed, diidmo qaadashada caqiido diimeed, ama diidmada looga qeybgalo ama looga qeybqaato dhaqan diimeedka;
- Waxaa laga yaabaa inaan kaaga baahneyn inaad ka soo qeybgashid ama aad ka qeybqaadatid howlo diimeedka walboo cad (oo ay ku jiraan howlaha ku lugleh waxyaabaha diimeedka muuqdo sida cibaadada, waxbarashada diimeedka, ama diin ka bixinta) oo uu bixiyo ururkeena, iyo ka qeybqaadasho walboo aad ka qeybqaadatid howlaha noocaas ah waa inay ahaataa iqtiyaar;
- Waa in aan kala saarno waqtiga ama goobta howlo diimeed walboo cad oo si gaar ah loo maalgeliyo (oo ay ku jiraan howlaha ku lugleh waxyaabaha diimeedka muuqdo sida cibaadada, waxbarashada diimeedka, ama diin ka bixinta) ee howlaha lagu taageeray kaalmada maaliyada Federaalka tooska ah; iyo
