## Special Slaughter Conditions — Instructions

For those involved with livestock exhibits at Washington Fairs, [WAC 16-19-110](#) allows for special slaughter conditions for animals sold at 4-H or FFA sales to buyers who wish to have their animal custom slaughtered and processed. If your sale needs to utilize this provision of the rules, please follow these steps:

1. Complete your portion of the attached Application for Special Slaughter Conditions.
2. Contact your local county health department/district and arrange for inspection of your intended site, and have them complete their portion of the application. Your portion, along with that of the local county health department/district, must be completed or the application will be returned as incomplete. All signatures and dates must be in the current year. WSDA will not accept applications with signatures dated from previous years.
3. Submit the application **at least 45 days prior to the sale** to:

A completed application, signed by the health department and the WSDA Food Safety Compliance Specialist will be your permit for this special slaughter and should be posted at the site during slaughter operations.

This application should only be used by fairs when slaughter at a federally inspected slaughter plant is logistically impossible, not for the convenience or monetary gain of custom slaughterers.
