




Selling Home and Garden (H&G) products?

Washington State Department of Agriculture (WSDA) pesticide program receives many questions from retailers and consumers about which products are considered Home and Garden (H&G) in the state of Washington. WSDA has classified certain federal and state General Use Pesticides as H&G products which allows a homeowner to purchase them without a pesticide license. In addition, the store does not need to record the customer's information at time of sale; does not need to hold a Pesticide Dealer endorsement on their Master Business License; and does not need to have licensed Dealer Managers.

Here is a tool to help you figure out if a product is considered H&G. Answer each question below and follow the arrows.



Example 1: State RUP

Note: The label does not indicate this aquatic pesticide is a RUP. Dealers must be familiar with the General Pesticide Rules detailing state RUPs (see WAC 16-228-1231 through 1238).

For control of annual and perennial weeds and woody plants in natural and production (plantations), forests for site preparation, mid-rotation release treatments, timber stand improvement activities, noncrop sites including industrial sites, rights-of-way (including roadsides, electric utility and communication transmission lines, pipelines, railroads, airports), irrigation and drainage ditches, canals, reservoirs, natural areas (including wildlife management areas, wildlife openings, wildlife habitats and refuges, parks and recreational areas, campgrounds, trailheads and trails), rangeland, and in and around aquatic sites and wetlands; also for perennial grass release, and grass growth suppression and grazed areas on these sites.

Avoid contact of herbicide with foliage, green stems, exposed non-woody roots or fruit of crops, desirable plants and trees, because severe injury or destruction may result.

Example 2: Federal RUP

Note: The label states "Restricted Use Pesticide."

Example 3: Category 1 - Danger/Poison

Note: "Danger/Poison" is clearly stated on the label.

Note: There will be an "Agriculture Use Requirements" box on the label.

Directions for Use

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only handlers may be in the application block from the start of the application until the entry restricted period ends, and in the buffer zone during the buffer zone period. For any requirements specific to your state or tribe, consult the agency responsible for pesticide regulation.

Agricultural Use Requirements

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard (WPS). No instructions elsewhere on the labeling relieve users from complying with the requirements of WPS.
